# **Key Findings**

### **Key Findings**

- 1Black voters are highly enthusiastic about the March 2024primary, and a majority say they are following the DistrictAttorney's race closely.

- Just over one-in-five Black voters (21%) support incumbent DA George Gascón—however, a strong plurality disapprove of his performance as DA and nearly half are undecided in the race.



Few have heard much about the other candidates in the race, leaving considerable opportunity to communicate with this key constituency.

### **Key Findings**

Black voters express considerable **concern about the direction of the Los Angeles County—homelessness, housing, and the rising cost of living rank as highly serious problems** facing the region.

A majority say they feel less safe than they felt one or two years ago and that crime has increased—a lack of resources and services ranks as the top reason for the increase, along with a decline in moral and family values, job loss and unemployment, and changes in law to reduce punishment for certain crimes.



**Overall,** however, a majority of **Black voters** do not believe criminal justice reform has gone far enough and **will be looking for candidates that speak to the complexity of the issues as opposed to a one-size-fits-all approach.**











Q: Would you say you feel safer today in Los Angeles County than you did a year or two ago, or would you say you feel less safe?















# A MAJORITY REJECT THE NOTION THAT CRIMINAL JUSTICE REFORM HAS GONE TOO FAR


**George Gascón** was elected District Attorney of Los Angeles County in 2020. In this role, he has made a commitment to reforming the criminal justice system, reducing racial disparities, and ending mass incarceration. As DA, he has enacted a number of reforms, including dropping some, but not all sentencing enhancements, eliminating cash bail, and aggressively prosecuting police officers for excessive use of force. He has been endorsed by Congresswoman Sydney Kamlager-Dove, Assembly members Reggie Jones Sawyers and Tina McKinnor, and the Los Angeles County Democratic Party, among others.

# CANDIDATE PROFILES: ARCHULETA, CHEMERINSKY, AND HOCHMAN

**Debra Archuleta** is a Los Angeles Superior Court Judge and previously served as a Deputy District Attorney for 25 years, where she focused on prosecuting crimes involving murder, rape, gang violence, domestic violence, embezzlement, among others. If elected, Archuleta has vowed to end what she refers to as Gascón's "catch and release" policy and plans to prosecute violent criminals to the fullest extent of the law. She has been endorsed by the Burbank and Glendale Police Officers' Associations.

**Jeff Chemerinsky** is the former Chief of the violent crimes prosecutions unit in the Los Angeles branch of the U.S. Attorney's office. As District Attorney, Chemerinsky will focus on prosecuting serious crimes such as gun crimes and "smash and grab" robberies, protect LA County's quality of life, and promote criminal justice reform through alternative sentencing and police accountability. He has been endorsed by LA City Attorney Hydee Feldstein Soto, former LA District Attorney Ira Reiner, and Civil Rights Attorney Connie Rice.

**Nathan Hochman** currently works as a private practice attorney. Before entering private practice, Hochman served as an Assistant US Attorney and President of the LA Ethics Commission. In 2022, Hochman ran as the Republican nominee for California Attorney General. He has served on numerous charitable boards, including Cedars Sinai Medical Center and the Los Angeles Jewish Community Relations Council. As District Attorney, Hochman plans to reverse Gascón's policies, prosecute environmental crime, and clear homeless encampments from public spaces. He has been endorsed by former LA County District Attorney Steve Cooley.





# CANDIDATE PROFILES: MCKINNEY, RAMIREZ, AND SIDDALL

Q: Based on this description, would you say you have a favorable or unfavorable opinion of...?

**John McKinney** is a Deputy District Attorney and has been a prosecutor for 25 years. He is known for leading the prosecution and conviction of the murderer of rapper Nipsey Hussle. If elected, he has vowed to repeal and replace every policy Gascón has enacted and plans to work to repeal Prop. 47. As District Attorney, McKinney will focus on public safety, victims' rights, and implementing a system of proportional justice to criminal justice reform. He has been endorsed by several local police associations and is one of only two African Americans in the District Attorney's race.

**Maria Ramirez** is a Deputy District Attorney. She has served as a prosecutor for 32 years with a focus on prosecuting gang violence and drug trafficking. Since 2006, Ramirez has served as the President of the Mexican American Bar Association. She has challenged George Gascón's policies not to pursue sentencing enhancements and for failing to try juveniles as adults. As District Attorney she will focus on public safety, restoring accountability, and implement a balanced approach to criminal justice reform.


**Eric Siddall** is a Deputy District Attorney. He has been a prosecutor for 16 years. He is a former president of the Association of Deputy District Attorneys and a past board member of the Latino Prosecutor's Association. As District Attorney, Siddall is committed to taking down violent street gangs, getting guns off the streets, and putting cop killers, serial rapists, and other dangerous criminals behind bars. He has also committed to working with local agencies and non-profits to address homelessness and plans to direct prosecutors to clear encampments and protect and clean up parks, sidewalks, and other public spaces.




